Please refer to this Ministry's letter no. 19012/01/2017-Edu/Scho dated 09.06.2017 (Copy enclosed) on the above cited subject. The detailed letter may please be seen at this Ministry's official website [www.tribal.nic.in under Scholarship Section].

2. In order to receive grants for their ongoing projects under the Schemes of "Grant-in-aid to Voluntary Organizations working for the welfare of STs", "Strengthening of Education of ST girls in low literacy areas" and "Vocational Training Centre", all NGOs/VOs shall hereinafter, have to furnish the details of Aadhaar number and Aadhaar linked Bank Account number of their end beneficiaries. The details of beneficiary shall have to submitted by NGO/VOs in MS-excel sheet in the following format:

- a) Name of NGO/VO:
- b) Project & its location :
- c) Name of Scheme under which grant applied:
- d) Year for which grant applied :
- e) List of beneficiaries (in MS-excel sheet)

3. In case the proposals of NGOs/VOs have already been forwarded to this Ministry by the State Government without the requisite details then the same may be obtained from the concerned Organization and forwarded to this Ministry (soft copy of the details in Excel Sheet may also be emailed at

reema.sharma@nic.in, s.titus@nic.in) after verifying the Aadhaar numbers of the beneficiaries, **failing which no grant would be released to the Organization.**

4. It is requested to ensure that all proposals of NGO/VOs should invariably contain the above information before forwarding the same to this Ministry.

5. The Notification dated 09.06.2017 is applicable to all the States and UTs except the States of Assam, Meghalay and Jammu & Kashmir.

In case the proposal of NGO/VOs has already been forwarded by the State Government, then the list of beneficiaries alongwith their Aadhaar numbers and Bank account numbers may be submitted to this Ministry immediately, failing which grant would not be released to the Organization. As already informed to all State Governments vide this Ministry's letter dated 9th June, 2017, the beneficiaries of the projects run by NGO/VOs who do not have the Aadhaar number had to enroll himself/herself to the nearest enrolment centre available in their local areas by 30th June, 2017
